Findlay Campus is up 3 students to 18. ▪ The Construction Inspector Certificate has 2 students enrolled this spring in Toledo and 1 in Findlay. ▪ Randy Germann stated that the Surveying program is very valuable and he hopes it continues. ▪ Leonard Michaels mentioned that PLSO members have been asked to promote the Surveying profession in the schools. 	<ul style="list-style-type: none"> ▪ The Department is involved in a number of recruiting events and visits and there are articulation agreements for various courses in the program. ▪ The CIV 210 class had fun grading the NAWIC project this semester. ▪ Owens Marketing Department will be targeting the Architectural and Surveying program in ads for a special Blade Architectural section that will be published soon.

Accreditation Status	<ul style="list-style-type: none">▪ Much discussion centered around the feasibility of ABET accreditation. Only the Electronics, Architectural and Mechanical programs on the Toledo Campus are currently ABET accredited. ABET has a problem with the Architectural program title and will no longer accredit Computer Science or Biomedical. This accreditation is expensive and does not help with the transfer of courses to four year institutions.▪ NAIT will be conducting a site visit on April 15, 16, and 17, 2009. Randy Wharton will notify advisory members if they are needed to attend the luncheon with the evaluators on April 16th.	<ul style="list-style-type: none">▪ Advisory members did not recommend keeping or dropping the ABET accreditation. They just wanted the program administrators to examine the situation carefully before making a decision.
