Enrollment and Retention Report	<ul style="list-style-type: none"> ▪ Toledo Campus Architectural program enrollment is down one student from last fall to 107. Findlay Campus is up two students to 17. ▪ The Architectural CAD Operator Certificate has one student enrolled on the Toledo Campus and one student on the Findlay Campus. ▪ The Construction Inspector Certificate has three students enrolled this fall in Toledo and none in Findlay. 	<ul style="list-style-type: none"> ▪ The Mechanical program is being deactivated. Enrollment numbers being reported are not accurate due to students declaring the wrong major. Those students currently in the program will be allowed to complete the program. ▪ The Surveying program is also being discontinued. ▪ The School of Technology (SOT) now has two part-time advisors that reside in the building who are dedicated strictly for SOT students.

The one objection Reed has voiced concerning this class is that Microsoft Word and Excel applications are not being taught strong enough. 	<ul style="list-style-type: none"> ▪ The hope is to have this problems solved by the spring meeting. Consideration will be given to offering a separate MS Word/Excel package course where Excel exercises can utilize Architectural applications.

Accreditation Status	<ul style="list-style-type: none">▪ All the School of Technology programs are accredited by the Association of Technology, Management and Applied Engineering (ATMAE) board (formerly known as NAIT).▪ All the Architectural courses submitted for the state-wide TAGs have been accepted which will assure transfer of these courses to Ohio four-year institutions.▪ The Architectural program also has 3 + 1 agreements with Siena Heights, Eastern Michigan and Ohio University.	<ul style="list-style-type: none">▪ The School of Technology has decided not to continue with ABET accreditation.
Other	<ul style="list-style-type: none">▪ A new Alternative Energy and Sustainable Systems degree is being introduced by the School of Technology. A 2.4 watt wind turbine has been placed next to the IET building and will be used for training purposes. Another 120 ft, 50 kilowatt wind turbine will also be placed behind the building.
