Enrollment and Retention Report	<ul style="list-style-type: none">▪ Enrollment in the Toledo Campus program is the same as last fall semester for a total of 17 students.▪ Enrollment in the Quality Assurance Certificate is up three students for a total of 4.▪ There is one student in the Six Sigma Green Belt Certificate.▪ Jim Gilmore distributed a sheet showing the number of QCT sections running this semester and the number of students enrolled in each section. There are a total of 295 seats filled in courses that are running for QCT.▪ The last ASQ section meeting was very heavily attended. Bob Mason and Jim Gilmore would like to see more student involvement at these meetings where students have opportunities to network.	<ul style="list-style-type: none">▪ Janice Skaggs and Patrick Gill are Title III grant funded Success Mentors who now have offices in the School of Technology. They are advisors plus – they help students with whatever school-related problems they might have. Both Janice and Patrick are visiting classes to introduce themselves and inform students of their services.
