

Owens' most important resource is its people. Since 1965, more than 30,000 alumni have joined the Owens Community College family, leading the way in giving back to the College and their communities. More than 75 percent of those graduates have stayed in the region. Here are some of their stories.

TRACY SEEGER

Registered Nurse, Class of 2001

Tracy Seeger always wanted to be a nurse, but delayed pursuing her dreams while she began working in a dental lab, got married and started a family. Later, when she decided to return to college to become a nurse, she researched her options and visited several colleges and universities. She chose Owens because she liked it the best. Seeger worked full-time while beginning as a parttime student and continued even once she picked up a full class load. She said, "The clinical experience at Owens was phenomenal. They used every available second to teach us. The faculty wanted us to succeed."

> Seeger has thrived in her nursing career, focusing on pre-operative holding. She takes pride in helping to calm patients as they prepare for surgery. Last year, Seeger moved to the newly built Wildwood Orthopaedic and Spine Hospital, one of only 30 free-standing orthopaedic hospitals in the nation.

JEROME GRAHAM

Marketing/Sales, Class of 1980 Growing up in Toledo, Jerome Graham knew he wanted to be a business man. He was influenced by his aunt and uncle who were business owners, even though it was still unusual for minorities to own a company at that time. Immediately after graduating from Penta County Vocational School with a degree in business, Graham enrolled at Owens. He said, "At the time, I wanted to start working as soon as I could, so a two-year degree seemed perfect for me." Following graduation, Graham began working in sales. A few years later, he heard of a sales position at a local radio station and applied, though he knew little about the radio industry. He was hired and embarked on a lengthy radio career both in Toledo and Detroit. Today, Graham is a Marketing Consultant at Urban Radio Broadcasting LLC in Toledo. He says, "My Owens education colors everything. Even a trip to the grocery store is different for me. I can see the marketing that goes into each product placement."

SUE NICHOLS

Dental Hygiene, Class of 1983 Sue Nichols initially thought she wanted to work in an office following high school, but learned over the course of one summer that this was not the career for her. Having chosen to study dental hygiene, Owens Community College was Nichols' number one choice. She moved from Tiffin to an apartment close to Owens, quickly became overwhelmed and wanted to quit. Encouraged by her parents, she stuck with the program and began to do well. The dental hygiene students were a close knit group and loved to practice their new skills on family, friends and fellow students.

Following graduation and passage of her board exams, Nichols began working two part-time jobs for established dentists. This flexible schedule met her career and family needs. Eventually, Nichols returned to Owens as a Clinical Instructor, excited to help a new generation of students. "Owens completely prepared me with a good, solid foundation to enter my field and succeed," said Nichols. Now, she says, "I lend my experience to complement what the students are learning in the classroom."

JAMES RHEGNESS

Business Management, Class of 1993 Jim Rhegness majored in business management at Owens Community College. While interning at Belmont Country Club, Rhegness was put to work in the kitchen so that he could learn how the entire operation worked, triggering a passion for the culinary arts. After graduating from Owens, Rhegness spent two years at the Culinary Institute of America in Hyde Park, New York in intensive culinary training. "I survived 'chef boot camp' because of my Owens foundation," said Rhegness.

As Rhegness embarked on his culinary career, his desire for a more family-friendly position led him to teach at Monroe Community College. Later, he jumped at the opportunity to move to Penta Career Center, and he has modeled the culinary program there to be a mini-version of the Culinary Institute. He says, "I am able to achieve my goals because of my start at Owens Community College."

The Success Tuition Assistance Program (Success TAP, formerly known as the Success Program) was created to bridge the gap between the federal financial aid received by a student and the cost of tuition and general fees at Owens Community College. Piloted in 2008 with Woodward High School in Toledo and Findlay High School, Success TAP subsequently expanded to include all Toledo Public high schools, Whitmer High School, Lake High School and all public high schools in Hancock County.

Since 2008, 141 students have received 165 Success TAP grants totaling \$186,080 to assist them in pursuing their education at Owens. Program criteria require that students attend full time (at least 12 credit hours per semester); in addition, many other students work one or more jobs to support themselves as their living expenses are far greater than the cost of tuition and general fees at Owens (\$2,044.42 for 15 credit hours as of Fall Semester 2012 or \$4,088.84 per year).

Additionally the Bridge Program was created in 2008 to help new Success Program students get ready for collegelevel academic work. It is an intensive seven-week comprehensive summer program that introduces students to college life and Owens' educational resources. Students become part of a learning community that includes mentoring, coaching and advising services throughout their first year at Owens.

Meagan O'Dell is a 2011 honors graduate of Bowsher High School in Toledo, a current Success TAP student and was a participant of the 2011 Summer Bridge to Success program.

O'Dell says that the Bridge Program taught her a lot and that the most valuable aspect was that "there are people in our corner no matter what."

In her first year as a Success Program student, O'Dell said that "without the Success Program grant I received, I would not have been able to attend Owens full-time."

The Success Program opened many doors and opportunities for O'Dell, who currently works as a student worker for the Bridge Program and Project DEgree. She was thrilled to share her experiences with the 2012 Bridge Program students.

A nursing major, O'Dell currently has a 3.4 CGPA and works a second part-time job off campus as she supports herself entirely. She often works at least 25 hours a week in each of her part-time jobs, in addition to attending Owens full-time. O'Dell enjoys working with people and is passionate about helping others. She plans to earn her State Tested Nursing Assistant (STNA) certificate in Fall 2012 and then to work in that field while completing her nursing degree. O'Dell has received a second Success TAP grant for the 2012-2013 academic year.

All students from eligible high schools who attend Owens full time and who qualify for at least some federal Pell funding are considered to be part of the Success TAP program. Some students qualify for Success TAP grants their first year, while others may qualify in subsequent years. The vast majority of Success TAP students (more than 80%) are first generation college students, whether or not they receive a Success TAP grant. In addition, over 83% of grant recipients test into at least one developmental education course. These factors mean that the intensive services provided to Success TAP students are instrumental in helping them succeed at Owens. For example, during the first four years of the Program, Success TAP grant recipients on average maintained a higher GPA than non-grant recipients, and higher course completion (retention) rates than non-grant recipients.

Owens' faculty and staff talk about Owens in their own words.

"I believe in Owens and its mission. To me, My Owens is very personal because this college is my college. I started at Owens back in the 1970s in the Records Office, but I've always been connected to the Office Administration program. Owens was still small then so to see the College grow to over 400 acres today has been amazing."

Promoting Student Success and Increasing Retention

From July 1, 2011 through June 30, 2012, the Owens Community College Foundation provided \$538,021 in program and scholarship support. More than \$180,000 of that total was in the form of scholarships for students, while more than \$350,000 was directed towards program support.

The financial support provided by and through the Foundation helps the College to fulfill its mission, serving our students and our communities, by promoting student success. One of the ways in which the College does this is through initiatives that increase student retention (course completion and graduation) rates.

Student retention initiatives are supported by the Foundation in two ways. First, the Foundation provides student scholarships that make college more affordable for students. Second, the Foundation supports retention initiatives funded by grant dollars that flow through the Foundation. In the past several years, grants have supported major retention efforts focused on cohort groups, intrusive advising and academic readiness support services. All these initiatives are proven to increase student course completion and graduation rates. In FY 2012, the Foundation of Connect 2 Complete, Gateway to College National Network, Project DEgree and Upward Bound, ensuring that these important retention initiatives will continue to benefit students across Northwest Ohio.

In addition to scholarships, the Foundation provides valuable support for a wide array of other college programs. For example, the Foundation funded the purchase of state-of-the art equipment and supplies that are benefiting students in the fine and performing arts programs, the School of Technology's alternative energy lab, and the College's community garden that provides service learning opportunities for students as well as fresh fruit and vegetables. Providing up-to-date equipment increases opportunities not just for students to learn but to excel, and this also positively impacts retention rates.

CONNECT 2 COMPLETE

A program of Campus Compact with funding from the Bill & Melinda Gates Foundation, Connect 2 Complete is a pilot project where peer advocates work with faculty in cohorts designed to help students be successful through community-engaged learning.

GATEWAY TO COLLEGE

A program that serves young adults (ages 16 - 21) who have dropped out of high school, allowing them to earn their high school diploma and college credits simultaneously.

PROJECT DEGREE

A program of the Gateway to College National Network, Project DEgree provides students (ages 18-26) with intensive individualized academic and social support and offers an engaging project-based curriculum within a learning community to help students complete their educational goals.

UPWARD BOUND

A grant program, administered by the U.S. Department of Education designed to encourage high school students to remain in school, enroll in a postsecondary institution and graduate with a degree.
