On Giving Tuesday, you came together and raised money to deliver much-needed support to students facing unexpected hardships. You helped us provide over \$10,600 of support to the Owens Student Emergency Assistance Fund. Thank you so much for your generosity!

With your funding, the Owens Community College

Foundation offered assistance through this program to students experiencing sudden financial hardships preventing them from being successful in their academic endeavors. Your gifts immediately impacted their circumstances by covering the cost of education-related expenses such as books, supplies, uniforms, and scrubs. We were able to offer resources to help cover expenses such as rent, mortgage, utilities, automobile expenses, public transportation, medical bills, child care, and more to students who needed it. With your support to the Student Emergency Assistance Program, our students no longer have to worry about not making it to class because they can't afford things such as gas, babysitters, or textbooks due to circumstances beyond their control.



Over 200 Grateful Students

When you unleash your power of giving, great things happen. One of the great things that you make happen every year is assisting Owens students with scholarships. Since 2002, the Foundation has disbursed more than \$2.6 million in scholarships to students because of donor support. This year alone, you have enabled us to award over 200 students with scholarships that totaled more than \$325,000! Scholarship amounts vary, but regardless of the amount granted, each award has a significant impact on Owens students' lives.

Over 385 students have applied to receive scholarship funds for the upcoming academic year. We award as many as we can with as much as we can and are grateful to the generous donors who make it possible to ease the burden of tuition to as many students as possible. •




In Their Own Words

Owens Community College welcomes a diverse community of learners. Our open admissions policy provides access and opportunity to a wide variety of students.

Owens Receives Award from OEDA

Owens Community College's Dana Advanced Manufacturing Training Center has been awarded the 2020 Annual Excellence in Workforce Development by the Ohio Economic Development Association (OEDA). This award recognizes unique approaches to workforce development and acknowledges an organization that has developed innovative practices and programs.

"We are pleased to have been recognized by the OEDA for the College's commitment to workforce development. The Dana Center represents the College's latest significant investment to directly impact Northwest Ohio's regional economy," stated Bill Balzer, interim president, Owens Community College. "A skilled workforce is critical to fill thousands of new and existing jobs in manufacturing and aligned careers throughout our region and the state. The Dana Center was specifically designed to meet these needs now and well into the future. We thank Dana Incorporated and other supporters for joining us in meeting the region's training needs for the new and incumbent workers for decades to come."

Owens was nominated for the OEDA award by project architect Tim Swartz from SSOE Group. Headquartered in

Investing in Innovation

In 2019, the Owens Foundation embarked upon a capital campaign to raise \$2 million for construction and equipment for the Dana Advanced Manufacturing Training Center at the Owens Community College Toledo-area campus. Thank you to Dana Incorporated, who kicked off the campaign with a \$1 million lead gift, and the Gene Haas Foundation for their incredible \$250,000 contribution.

The new 59,000 square-foot Dana Center will expand existing education and training opportunities for students and industry partners in advanced manufacturing, skilled trades, and related fields. Major labs include the 7,000-square-



foot Gene Haas CNC Machining lab along with Robotics and PLC, Electrical, Mechanical, Pneumatics, Hydraulics, CAD, HVAC, and Plumbing. Dana Incorporated and the Gene Haas Foundation's significant investments in Owens will provide training and increase skilled personnel entering the workforce to meet the industry's urgent employment demands.

So far, the campaign has raised \$1.76 million. Fundraising efforts continue in order to secure the remaining \$240,000, with additional naming rights still available within the facility. Stay tuned for more information regarding the official grand opening ceremony happening this fall to celebrate this innovative facility.
